Meeting called to order at 10:30 a.m. at the Best Western Motel in Hood River, OR on 12/6/15 by Kathy Parker, since Niki Slattery-Abilla is unable to attend. Roll call was taken.

Membership: 6 member clubs joined out of 16 possible clubs. Clubs joining: WSPHC, OPHC, COPHC, SWWPHC, PNPHC, BCPHC. Rainier Club is not rejoining since they feel they didn't get the value for their money.

The contract details including cost, deadlines, etc. will be published on website, facebook, emailed to club secretaries, and to delegates so they can be seen by the membership. M/S/P.

Discussed a fee to be charged for Declaration of horses – tabled until Jan. 30th meeting. Declaration has to be received by 10 days after the first show to be recorded. Information on the website but it hasn't been maintained.

Need to have a recognition of members who are not showing, ie. Trail ride hours. May consider in 2016. Linda will check with APHA. – tabled.

APHA Board of Directors: reimbursement NWCC guidelines that have been established 10% pointskeeper, 20% to APHA national Directors, and 70% awards. To be reimbursed the Director is required to write a report and attend 1 meeting to collect the funds. Funding is from \$1.00 charge per class. The report needs to be a comprehensive written report that includes a report from your standing committee and is to be received within 30 days of the meeting. A screen shot of APHA passed

resolutions is not acceptable. All receipts must be submitted to the Treasurer by Dec. 15th with the report. M/S/P.

Show Schedule: Must show under 8 judges at 4 shows to win Hi Point: OPHC – Albany – April 8-10th – 4 judges, OPHC –Albany - Sept.30 to Oct.2 – 4 judges- Triple Crown, WSPHC – Monroe – July 14-16 – 6 judges – Mark Smith, Sandy Gerkowsky, Sid Larsen, Dave Parlier, Brad Kern, and Kathryn Bagatta.
