## **2026 NWCC YEAR END AWARD RULES – Open Show / All Breed Events**

### **GENERAL RULES AND POINTS TABULATION: ALL DIVISIONS**

1. All NWCC rules will be observed. Program open to All Horses being shown in non-breed registry classes (not PtHA, AQHA, APHA, etc.). We are looking for horses competing in all-breed competitions (open shows, all breed classes at breed shows, NSBA, etc.)
2. All exhibitors of above horses must be in good standing with all NWCC member clubs. Any exhibitor who has any show fees outstanding with any NWCC approved show at the end of the point challenge period shall be ineligible for NWCC year end awards.
3. A fully paid current membership in an NWCC club is required. A youth may be part of a Family Membership but must be listed on the membership list. Adult children (19 years and over) do not qualify under a Family club membership for NWCC. Membership to a youth only club does not constitute membership for NWCC purposes.
4. Please Note: Points earned prior to membership will not be counted with the exception that Exhibitors have 10 days after the conclusion of a show to join an NWCC approved club for those show points to count towards NWCC year end awards.
5. It shall be the responsibility of each NWCC Member Club Secretary to provide the NWCC Pointskeeper and NWCC Secretary with accurate membership lists, including dates joined, for point tabulation. Club membership lists must be emailed to NWCC Pointskeeper and NWCC Secretary and updated immediately as new members join or information changes. All Family, Ranch & Company memberships to be listed with exact names of members.
6. An individual's NWCC points will not be tracked until the NWCC Treasurer has received a completed declaration form and the Open Show Division sign-up fee per horse. Declaration forms must be RECEIVED by the NWCC Treasurer before the first show or within 10 days of the show you want to count for year-end awards.
7. Owner/Exhibitor will be responsible for submitting a copy of their show placings (including number in the class) as well as a copy of the show class list to the NWCC open show pointskeeper within 15 days of a show (recreational riding hours no later than the 15<sup>th</sup> of the following month) for that show to be counted. Points will not be counted in an "all other breed" class if also exhibit in a Breed specific class (eg: APHA, AQHA, PtHA, etc.). Grand & Reserve halter is not counted.
8. The show season will last from November 1<sup>st</sup> through October 31<sup>st</sup> each year. Awards to be given in all qualified divisions. A horse must accumulate a minimum of 25 NWCC Points in a show division or 10 riding hours in the recreational riding division. Exception weanling halter classes - a minimum of 10 NWCC points must be accumulated. Points will be calculated using the chart at the end of the rules.
9. TIES: Ties will be broken in the following manner: The horse accumulating equal points but showing the least number of times will receive the award. If this is equal, a coin flip.
10. **DIVISIONS:** NWCC will recognize awards in 6 divisions (no age divisions – open to all ages) with Special Recognition to the highest point earning Paint Horses. NOTE: you cannot accumulate points in Walk/Trot & Loping classes at the same show.
  1. Western (western pleasure, western riding, ranch classes, gaming, western dressage, etc.)
  2. English (English pleasure, hunter under saddle, over fences, dressage, etc.)
  3. Equitation (showmanship, fitting & showing, horsemanship, western eq., hunt seat/english eq.)
  4. In Hand (halter, color, ranch conformation, longeline, in hand trail, etc.)
  5. Walk/Trot (all walk/trot classes – western, english, showmanship, equitation, etc.)
  6. Recreational Riding (those hours ridden in compliance with the PAC program)

***POINT SYSTEM for Recreational Riding***

- There will not be a point system – we will track & accumulate each hour ridden

***POINT SYSTEM for Dressage Events***

- Your score will be converted to the appropriate APHA PAC credit system and then extrapolated to how many horses that number of credits would normally apply – then placings will be used in the above table (for example, a score of 61 equates to 2 PAC credits which would normally be 6 horses in a class – so we would use 6 horses in the class and use your test placings to calculate NWCC points).

***POINT SYSTEM for 4-H Danish, FEI Levels, or Endurance***

- If we have exhibitors competing in those types of events, the NWCC Board will create a point system commensurate with the APHA PAC Credit system that fits within our NWCC traditional rules

**NOTE: CURRENT YEAR CLUB MEMBERSHIP MUST BE PAID & DECLARATION FORM RECEIVED WITH SIGN-UP FEE BEFORE POINTS CAN BE ACCUMULATED**

Challenges to or questions about the NWCC points must be made to the NWCC Board no later than 14 days after the final points are posted at the end of the year. The NWCC Board reserves the right to decide all challenges or questions.

**ALL NWCC AWARDS MUST BE PICKED UP AT THE BANQUET UNLESS PRIOR ARRANGEMENTS HAVE BEEN MADE. FORFEITED AWARDS WILL BE REUSED OR DONATED AT THE DISCRETION OF THE NWCC BOARD.**

*For 2025-26, e-shows will again be counted in the NWCC program. You must still submit documentation to show your placings and the number of horses in your classes as well as a show bill for that e-show.*
